

Finding the Patent for the Clayton Blantz “Tool” Patented August 25, 1914 (not 1915) (D46,310)



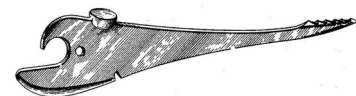
I first acquired the “tool” shown in the mid-1990s and traded it to Mike Schwimmer who was an avid CBO (Cigar Box Opener) collector. In 2012 his collection was being sold on eBay and I got it back. Tommy Campnell acquired one a couple of years ago and was convinced the jagged end was a corkpuller. We put the “ace patent searcher”, Josef L’Africain, to find the patent. The problem was almost all U. S. patents are issued on Tuesdays and 8/25/1915 was not a Tuesday so no luck finding it. That is until January 7th, 2022 when I first tried changing the day with no luck, but when I backed down the year to 1914, August 25 was a Tuesday. Using the keyword “tool” found the patent quickly. They do sometimes have the wrong date. Patent drawing shows the exact piece. I was excited as I scrolled down to the patent information.

CLAYTON H. BLANTZ, OF LEBANON, PENNSYLVANIA. DESIGN FOR A TOOL. 46,310. Specification for Design. **Patented Aug. 25, 1914.** Application filed June 24, 1914. Serial No. 847,126. Term of patent 3½ years.

To all whom it may concern: Be it known that I, CLAYTON H. BLANTZ, a citizen of the United States, residing at Lebanon, in the county of Lebanon and State of Pennsylvania, have invented a new, original, and ornamental Design for Tools, of which the following is a specification, reference being had to the accompanying drawing, forming a part thereof. The figure is a perspective view of a tool showing my new design. I claim: The ornamental design for a tool, as Shown.

The patent is finally found and patentee says nothing about the functions of the “tool”. It is obviously a bottle opener, CBO Hammer, CBO, gas key and we still are not sure about the jagged end. If it is a corkpuller it is worth much more than being a “pipe reamer” or whatever died in Blantz’s head.
